## Dream Theatre Slide Show Advertising Contract

Dream Theatre will provide slides based upon your individual needs: logo, lettering, color, etc. Customers may submit slides as well, subject to Dream Theatre approval. All customer-submitted slides are subject to alteration as deemed necessary by Dream Theatre. Changes will be approved by customer.

Dream Theatre's cost is based upon the guarantee that your slide will be shown twice a day, on most weekends, with the slide show starting fifteen (15) minutes prior to show times, or as time allows between shows. Your slide will be seen for up to seven (7) seconds. There is no cost to you for any additional shows and matinees the Theatre may choose to run.

Dream Theatre cannot be held responsible for any incorrect information on slide after order is placed and approved, or any equipment failure. We will do our best to fix and/or replace any equipment in a timely manner.

Options for advertising are as follows:

- 2 Identical slides- yearly cost is \$200 with a minimum of one half (1/2) or six (6) months paid in advance totaling \$100. This new fee includes any animations added to slides
- 2 Different slides- yearly cost \$225 with a minimum of one half (1/2) or six (6) months paid in advance totaling \$112.50. This new fee includes any animations added to slides
- \*NEW\*** 2 Identical slides with video- yearly cost \$230 with a minimum of one half (1/2) or six (6) months paid in advance totaling \$115. Fifteen (15) second limit.
- \*NEW\*** Bi-yearly advertising- 2 identical slides changed every six (6) months- yearly cost is \$250 with a minimum of one half (1/2) or six (6) months paid in advance totaling \$125.
- \*NEW\*** Monthly advertising- 4 week cost is \$85 for 2 identical slides and needs to be paid at least one (1) week in advance.
- Weekend advertising - 3-day cost is \$25 for 2 identical slides, payable in advance. One week notice is required.

Upon acceptance of this Agreement you have the option to cancel after the first six (6) months with thirty (30) days written notice. The remaining balance will be payable thirty (30) days prior to the end of the six (6) month. Prepaid advertising is non-refundable
